Re: I-129F K3 Petition Review

Dear Sir:

Enclosed is how I would assemble your I-129F petition package. You should replace and update some pages as described below. You should replace originals with copies. You should remove all staples. I have used a simple clip to hold the package together. When you finalize the package you should use a two hole punch and acco fasteners (enclosed). Punch holes at the top of each page. Finally you should attach tabs (also enclosed) to each separate section to the petition. Identify each tab to match the item number on the cover letter.

1. Replace [REDACTED] 's G325A's with the originals that she has signed.
2. I-129F. Note that the fields that you can type into, are only so big, if you type more than what fits the field, the extra characters will be lost when you print out the forms. This defeats the purpose. So wherever you see the fields have been truncated, go back and abbreviate. Then print out and sign and attach all copies. Also in the case that a field is not big enough, as in question #9. only write "See Attached" on the form, and attach a separate sheet.
3. Your G325a. Under former wives, only write "See attached" on the G325a, and attach a separate sheet, to each copy of the G325a. That means four times. Do not include the instructions sheet.
4. You should assume that this I-129F package is the only set of documents that the reviewer will see. References made to the documents you previously sent when you submitted the I-130 are not helpful. Pretend that the I-130 does not exist. This I-129F package must be complete and stand by itself.
5. Photos. You only need to show a few photos, from each trip. I have chosen a few. You can choose others if you like. Note: Only choose photos that have both YOU and [REDACTED] in the picture. Only choose photos that show both of you happy and affectionate.

6. I have retyped your cover page. I will send a copy of this via email. You can modify it as you want, then print out any changes.

7. Your letter on the relationship. The letter is ok, it gives the feel of a genuine and lasting relationship. One change however, I recommend that you delete the second to last paragraph, detailing all her family problems. It is really off point and you do not want to suggest even the smallest hint that this marriage may be for her to escape family problems.

8. Letter of Intent. Since you are already married, the Letters confirming your intent to marry, are no longer needed.

9. Replace what you need to, then finalize the package and put it into order. Do not send originals to USCIS. Replace originals with clear legible copies. I recommend you make two copies of the final package, one for you and one for [REDACTED]. Then after making copies, use a two hole punch and acco fasteners. This is the how I make all the packages I prepare start-to-finish. I have enclosed extra fasteners for you. You can find a two hole punch at a copy shop. Also in the final petition to be sent to USCIS I always attach tabs to the bottom of the first page of each section. This makes it easier for the reviewer to quickly see any document he needs.

What you should do now:

A. Reassemble the petition. Make changes as needed. Replace pages as needed.

B. Sign and Date wherever indicated.

C. Make copies. Bind package.

D. Your petition should be sent directly to:
